1. I acknowledge that I have read and I understand the Central York School District High School Student/Parent Handbook and all of its contents and I agree to abide by all the rules and regulations contained therein. *I further acknowledge that the Central York School District may have to educate my student through virtual platforms chosen by the School District. In the event this occurs, I hereby consent to the use of a virtual learning platform, including but not limited to Zoom, to continue educating my student.*
2. I understand that I will not be allowed into the school building without a mask and will be expected to wear the mask throughout the day, except as otherwise allowed via mask breaks and/or instructions from District staff. I acknowledge that refusal to wear a protective face mask, face covering, or face shield, as ordered by the Governor of Pennsylvania and the Pennsylvania Secretary of Health, will be considered an act of insubordination and will be handled in accordance with discipline for acts of insubordination, as outlined in District policy, handbooks, and codes of conduct.
3. I understand that, per Policy 831 (Remote Learning, Livestreaming, and Zoom):

### **PARENT(S)/GUARDIAN(S):**

- When my student is in the classroom on the District campus, his or her interactions may be captured and livestreamed to students engaged in instruction off the District campus.
- When student is engaging in instruction from a site not located on the District campus, the livestream may capture the visual and audio interactions taking place in the remote setting.
- Recordings of instruction, including but not limited to, hybrid class livestreams, Zooms and pre-recorded instruction, are the property of the District. (See **Policy 815** Acceptable Use of Computers, E-mail, Network Resources, and Internet Access).
- Should I receive a recording of a hybrid class livestream it is because you have a legitimate educational interest in my student's education.
- Should I receive a recording of the livestream I am obligated to abide by privacy protections and shall not share this livestream recording with anyone, even if it is the parent of another student in my student's class. **Only the District is authorized to share livestream recordings.**
- I shall utilize the livestream recording only for the remote instruction of my child.
- Should I violate such privacy requirements – i.e. share this livestream recording with anyone or on the website or on social media – I will be prohibited from gaining access to future recordings.

### **STUDENT:**

- Recordings of instruction, including but not limited to, hybrid class livestreams, Zooms and pre-recorded instruction, are the property of the District. (See **Policy 815** Responsible Use of Internet and Network Resources, and **Policy 224** Care of School Property).
- Should I receive a recording of instruction, it is to be used by me only for educational purposes as instructed by my teacher.

- Should I receive a recording of instruction I am obligated to abide by privacy protections and shall not share this recording of instruction with anyone, or edit or misuse it in anyway, even if it is with another student in my class. **Only the District is authorized to share recordings of instruction.**
- I shall utilize the recording of instruction only for remote instruction.
- Should I violate such privacy requirements – i.e. share this recording of instruction with anyone or post it on the website or on social media, or in any way edit or misuse the recording – I will be prohibited from gaining access to future recordings and may be disciplined in accordance with **Policies 224 and 815.**
